

TEXT TO WIN

COCA-COLA / SUMMER BLAST TEXT TO WIN SWEEPSTAKES

APPLE IS NOT A PARTICIPANT OR A SPONSOR OF THIS PROMOTION.

BY SUBMITTING AN ENTRY VIA TEXT MESSAGE, ENTRANTS CONSENT TO RECEIVE UP TO FIVE (5) TEXT MESSAGES VIA AUTOMATED TECHNOLOGY FROM THE SPONSOR REGARDING THIS SWEEPSTAKES.

1. **ELIGIBILITY:** The Coca-Cola / Summer Blast Text to Win Sweepstakes (“Sweepstakes”) is open only to legal residents of Hawaii who are 18 years of age or older at the time of entry. Employees of Coca-Cola Bottling of Hawaii (“Sponsor”) and the “Promotional Participants” (i.e., Maui Soda & Ice Works, Ltd., The Coca-Cola Company, Coca-Cola Bottlers, Gage Marketing Group, LLC and each of their respective related parent companies, affiliates, subsidiaries, agents, advertising and promotion agencies and suppliers that are involved in the development or execution of this Sweepstakes) and each of their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister and/or spouses of each) and/or those living in the same household of each are not eligible to enter or win a prize. 2. **AGREEMENT TO OFFICIAL RULES:** By participating in this Sweepstakes, entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor, which are final and binding in all matters related to the Sweepstakes.

3. **TWO WAYS TO ENTER:**

A. Beginning on 7/01/19 at 12:30 AM Hawaii-Aleutian Time Zone (“HAST”) through 9/02/19 at 11:59 PM HAST, enter from your text messaging enabled wireless phone by texting the keyword BLAST to the shortcode 55678. Once your text message is received, you will receive a reply text message asking you to indicate your date of birth (MM/DD/YYYY) and the 2-letter U.S. postal abbreviation for your state of residence. After you reply to that text message with an eligible date of birth and state of residence, a reply message will be sent to you and you will receive one (1) entry into the Sweepstakes. If you do not reply with an eligible date of birth and state of residence, you will not receive an entry into the Sweepstakes.

The text messaging method of entry is designed to work with most of the major wireless carriers in the United States, but Sponsor makes no guarantee that any particular wireless service provider will participate. The wireless phone that is used must be capable of sending and receiving text messages. Entrants should check their phone’s features to see if they have that capability. **Wireless service providers may charge entrants for each text message sent or received, including any error message that is sent or received in connection with the Sweepstakes.** Entrants should consult their wireless service provider’s pricing plan for details. B. **ALTERNATE METHOD OF ENTRY:** To enter without a using a text messaging enabled wireless phone, on a plain piece of 3” x 5” paper, hand print your complete name, street address (no P.O. Boxes), city, state, ZIP code, date of birth (mm/dd/yy), plus daytime phone number. Mail entry in a hand-addressed, business-size (#10) envelope with first-class postage affixed, to: Coca-Cola / Summer Blast Text to Win

Sweepstakes, Coca-Cola Bottling of Hawaii, 949 Mapunapuna St., Honolulu, HI 96812. Entries must be postmarked by 8/26/19 and received by 8/29/19. No mechanically reproduced entries permitted. Illegible or incomplete entries are void.

4. RANDOM DRAWING/WINNER NOTIFICATION: Potential prize winner will be selected in a random drawing held on or about 9/02/19 from among all eligible entries received. The Sponsor-specified theme park tickets are valid during normal operating hours only. Operating hours and availability of attractions and shows are subject to change without notice. Some special events may be separately ticketed. Except as otherwise indicated herein, all tickets specifically exclude admission to special or separately ticketed "hard ticket" entertainment events. The theme park tickets are not redeemable or exchangeable for cash and are subject to all terms and conditions of use as established by issuer. The theme park tickets expire on 12/31/19.

"Authorized account holder" is defined as the natural person in whose name the wireless account has been issued and the services are billed. Entrants may be requested to provide Sponsor with proof that the participant is the authorized wireless device account holder of the wireless device associated with the account/submission. Any use of robotic, automatic, programmed or the like methods of participation will void all submissions by such methods and be deemed tampering. Sponsor reserves the right to prohibit the participation of an individual if fraud or tampering is suspected, or if the individual fails to comply with any requirement of participation as stated herein or with any provision in these official rules.
